# PRIVACY POLICY OF MOTORSPORT SOUTH AFRICA



#### **GENERAL**

Motorsport South Africa (MSA) is committed to safeguarding your privacy on-line. The purpose of this Privacy Policy is to tell you what personal information Motorsport South Africa collects about you and the purposes for which it processes this information. ## **INFORMATION COLLECTED**
